FILLING OUT THE RENEWAL FORM

RENEWAL PAYMENT

DUES THIS YEAR WILL BE DUE BY FEBRUARY 15H

Dues later than 30 days will incur a \$50 additional fee plus the appropriate annual dues. Dues later than 60 days will require repayment of the initiation fee of \$150 plus the appropriate annual dues. So for this year:

\$50 additional fee begins on MARCH 15th.

\$180 Repayment of initiation fee requirement begins on APRIL 15th

We no longer send you anything back as proof of payment. This practice has been a considerable savings for the club. Please watch your credit card statement or bank statement to verify that your payment has been received. It may take as long as two months for your payment to appear on your statement.

CLUB COMMUNICATIONS

ASSOCIATE MEMBERS

ASSOCIATE membership is for a spouse or domestic partner of a member. It is not for a sibling, an adult child or a friend. If your associate would also like to receive the "weekly" newsletter, please direct him or her to the website above.

JUNIOR MEMBERS

JUNIOR membership is for a child, step-child or grandchild of a member. The junior membership ends when the child turns 18 years of age. At that time, the junior needs to take a safety briefing and be processed as an adult member if the junior wishes to remain a member of the club. The initiation fee associated with an adult membership is waived if the junior holds a current membership when he or she transfers from junior to adult member.

If a junior member is transferring to an adult "student" membership, full-time school enrollment information is required.
